Discussion:

- The meeting was called to order at 7:12 PM.
- The minutes for the July HOA Board meeting were approved by the Board.
- Previous action items were reviewed and updated in the table below.
- Treasurer's Report
 - The transition from the former treasurer, Ms. Ann Kainec, was completed.
 - This month's Treasurer's report was sent to Mr. Zsidai and was available in the meeting.

HOA Finances

- A motion was made and seconded to maintain our HOA checking and savings accounts at Truist for the present. The motion was passed.
- A motion was made and seconded to investigate moving the HOA's funds to a new bank and accounts with interest rates of 4% or above and the treasurer will have the authority to make those moves. The motion was passed. See action item 2023-6.

HOA Fence

 There is a broken board along Georgetown Pike. Mr. David Whelan has a board and will take care of it.

- Matt Westbrook brought a couple of issues to the HOA Board
 - Regarding speed bumps in the neighborhood: The HOA can purchase speed bumps (VDOT will not purchase them) which the HOA can install that would be bolted into the road. The challenge is that VDOT might remove them and those types of speed bumps can be easily damaged by snow plows. A motion was made and seconded for the HOA to paint a wide "stop" line on Riva Ridge Rd at the Wynkoop Dr intersection's stop sign and to purchase 2-4 traffic signs (e.g. 18"x24" and ~\$50 each). The motion was passed. See action item 2023-7.
 - Regarding getting gas service to homes in the HOA: Washington Gas provides gas service to this area. There are several homes that have gas service and more that would like to get service. Mr. Westbrook will contact Washington Gas and get information for how to get gas service for more neighbors. See action item 2023-8.

Chili Cookout Event

- The invitation was sent to the HOA.
- Since this is now a community event, it was requested that the HOA fund one or two kegs for the event. A motion was made and seconded for the HOA to fund beverages for not-to-exceed \$400. The motion was passed.

HOA streets

- Only Riva Ridge Dr. has been repaved recently. The other neighborhood streets have several maintenance issues and need to be repaved.
- Mr. Zsidai completed an on-line VDOT form to report paving needs and upload pictures. He submitted a request for maintenance for Wynkoop Dr. VDOT only patched a few small places. He will work with VDOT to get Wynkoop Dr., McMillen Ct., Schindel Ct. and Van Dusen Ct. repaved. See action item 2023-9.
- Encroachment of 1008 Springvale Rd. onto Foxvale HOA common area
 - The owners need to remediate their property to meet Fairfax County Resource Protection Area (RPA) requirements and also remove the basketball court and the fence on Foxvale HOA common area land. Repair has been long delayed.
 - Mr. Tom Hixon has been following this issue for the HOA. There may need to be further legal correspondence from our HOA to get the Foxvale common area land restored at this point. Mr. Zsidai will follow-up with Mr. Hixon.

Common Area for Drainage Issues

 Before the meeting, Mr. Zsidai and Mr. Long identified six (6) areas where culverts into HOA common areas need to be repaired and/or water is pooling. An option is to let the grass or wildflowers grow in those wet areas to soak up the water. Mr. Long will be requested to ask Sullivan Landscaping for their opinion

- on how to address these areas. Depending on the prices for remediation and HOA funds, remediation may need to be phased in. See action item 2023-10.
- Culverts that run under individual driveways get clogged up with leaves. The
 question was raised whether the HOA should get involved to address fixing those
 metal culverts that have become crushed and hinder drainage.
- Urgent Tree Removal Authorization
 - O It was discussed that it takes too long to get approval from the HOA Board when trees need to be removed or otherwise maintained and the opportunity to get the damaged trees addressed can be delayed. A motion was made and seconded to give Mr. Long the authority to spend up to \$1500 for urgent tree removal/landscaping needs when a need arises. The motion was passed.
- The list of brainstorming ideas from the July meeting will be further addressed in the October meeting.
- The motion to adjourn was unanimously accepted and passed and the meeting was adjourned at 8:15 PM. The next scheduled meeting of the HOA Board will be held 14 October at the Great Falls Library at 7:00 PM.
